**Membership Fees**

Membership fees will fall due annually on April 1st and will be payable in accordance with the terms of a specific invoice sent at that time. If any fee remains unpaid for 28 days from the date notice is given to the Member, the Cuba Initiative shall be entitled to suspend or terminate the Membership. In cases where a member joins mid way through a period, a pro-rata fee may be agreed.

**Confidential Information**

Each Member shall ensure that it does not disclose any Confidential Information, which may come into its possession, custody or control by reason of its Membership. Confidential Information means all data and papers, materials and information in whatever format or medium it is held, which is held or compiled by, or supplied to the Members by the Cuba Initiative, and which is identified by the Cuba Initiative as being Confidential Information.
